## Coronavirus Aid, Relief, and Economic Security Act Required Reporting – 45-Day Report October 3, 2020

In accordance with the reporting requirements of Section 18004(e) of the Coronavirus Aid, Relief, and Economic Security Act, Texas A&M International University (TAMIU), an institution receiving funds under this section, is providing the following information:

1. TAMIU acknowledges that the University signed and returned to the Department of Education the Certification and Agreement. The institution further certifies it will use a minimum of 50% of the funds, or \$4,750,878.00, received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
2. TAMIU will receive \$4,750,878.00 from the Department pursuant to the University's Certification and Agreement for Emergency Financial Aid Grants to Students.
3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of October 3, 2020 is **\$2,436,300**.
4. The estimated total number of students at TAMIU eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act is **5,545 for Spring, 2,288 for Summer, and 5,975 for Fall**.
5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act is **1,040 for Spring and 1,120 for Summer** as of October 3, 2020. Fall awards are scheduled to be disbursed in mid-October.
6. TAMIU has awarded grants of up to \$1,500 under Section 18004(a)(1) of the CARES Act. Currently enrolled students were able to apply for grants via a simple online application process. The TAMIU Emergency Services Committee received the applications, reviewed them for completeness and eligibility under the CARES Act, and coordinated the awarding of the funds. Eligible students were able to apply for grants for expenses related to the disruption of campus operations due to coronavirus, including housing and food insecurity, medical expenses, and lack of educational support and supplies (including technology).
