# Grants Development

- I am the University Chief Research Officer
- In 2008, I was the Project Director of the NIH-funded Extramural Associate Research Development Award. I participated in an 8-week training at the NIH is Bethesda. The primary goal was to develop an Office of Research and Sponsored Projects at Texas A&M International University.
- In 2009, I oversaw the development of the TAMIU Office of Research and Sponsored Projects. I hired an outstanding staff. Extramural funding increased from \$150,000 in 2007 to a current five-year average of \$12.5 million per year in external funding.
- My staff is frequently cited as one of the best run units on campus and we work very well together. Faculty members seek us out for training. They work with us on finding the right proposals to pursue and we go far beyond their expectations in providing support for their proposals.
- I oversee the University Research Council to administer an internal grants program that offers funding for University Research and Creative Projects.

- Since 2008, my office has worked closely with the TAMIU Office of Grants and Contracts to support grant and contract awardees with general administration for their project. This includes direct training and support to staff assistants, meetings and phone calls to purchasing and Human Resources, as well as working with the accountants for budget administration.
- I make frequent check-ins with awardees to seek opportunities to provide support and increase their levels of success in achieving their goals.
- Provide regular trainings and work with administration on the understanding of "allowable, allocable and reasonable" budget use for awards.

# Student Research & Graduate Education

- Since 2009, Coordinated the TAMIU LBV Student Research Conference averaging over 200 student research posters or presentations per year.
   Additionally, coordinated presentation of an average of 35 students per year competing in the Texas A&M System Pathways student research conference.
- Developed a program to fund 12 Graduate Student Summer Research Fellows providing summer stipends for students to work with faculty to develop their thesis and prepare their work for conference presentations and potential publications.

- Since 2009, worked closely with the Dean of Graduate Studies to meet one-on ones with talented students to encourage them to attend graduate school at TAMIU or elsewhere. Supported students in developing their applications for Fellowships, Assistantships, and other funding sources.
- As a faculty member, I have mentored students and prepared them to attend many of the most prestigious Ph.D. programs in the nation, including one student that was honored with the highly competitive Robert Wood Johnson Health Fellowship.
